- Songs should approximately 4 minutes in length.
- Entries must be made by August 6 to correspond with stall reservation deadline.
- Freestyle entry form must be completed in full for entry acceptance.
- Music must be submitted at show office by 6 pm the evening before the class. Music must be in mp3 form, wav form, or on original CD.

**AWARDS:**

- Awards will be presented to the 6 highest scoring contestants.
- Contestants and horses should be present in costume for awards ceremony.
